Developing Recreational Infrastructure

When new recreational trails or other infrastructure are proposed for your town forest, your first step should be to coordinate these efforts with pertinent plans, including your town plan and applicable regional, transportation, and wildlife plans.

This should be part of a comprehensive focus on minimizing impacts to wildlife and habitats, waters, and other natural resources as well as historic and cultural resources.

Credit – The Vermont Town Forest Stewardship Guide: A Community Users' Manual for Town Forests, Page 38.

- Successful Community Forest projects require significant commitments on the part of the community.
- ✓ Community involvement should not be a distraction but should be encouraged.
- ✓ Community Forests secure the rights to an important access at the local level so that decisions about how the land will be managed can be made within the community.
- Most of the projects as initiated and managed by volunteers within the community. The community must make some degree of financial commitment, and the community is responsible for the long-term stewardship of the resource. This requires "readiness and interest" on the part of the people within the community.
- Individual or a group of individuals in the community needs to provide leadership and vision. This person or group should be well respected and have the interest, capacity, and stamina to promote and shepherd the project and to galvanize resources. Communities need access and a good local person or group because "it has to matter to someone there."

- 1. Moose Mt. review and ok.
- 2. SELT study and final layout.
- 3. Approved grant, (Late April 2022)
- 4. Right weather.

Work done so far in 2021

- 1. Help on new Rattlesnake trail.
- 2. Upgrade water issues and debris on the Lake trail.
- Brush control and mowing. After heavy logging brush can be a major problem for the first 15 years.
- 4. Non-Birch ridge, upgrade Den trail.

Problem areas to be discussed

- Beaver flow on class 6 Mountain Pasture Road. In years of heavy water flow and warmer temps unsuitable for snowmobiles. If SELT and one abutter allow we could reroute. If not, and abutter allows we could drain as it is a public road, open to the public and town has some rights to maintain.
- Corridor 22 by Bickford, last year talked of reroute by a vinal pool and few upgrades, Ok'ed by trails, no input from SELT. It is useable now in winter, but if SELT wanted, we would upgrade to three season trail.








Figure 10A-30—The base design reflects the mountainous terrain. Le Conte Divide, Sierra National Forest. North Pacific BEIG Province.


